



## Application for Affiliation

.....("the Club") hereby applies for Affiliation to field teams in the football competition(s) administered by the AFL Sydney Juniors ("AFL SJ") . Upon acceptance of this application by the AFL SJ, the terms set out below will record the agreement between the AFL SJ and the Club.

### Terms & Conditions

1. The Club shall at all times:-
  - (a) In all respects comply with and observe: and
  - (b) Use its best endeavour's to ensure that each of its officers, players and volunteers in all respects comply with and observe,
    - (i) in so far as they affect the Club, any document, rules or regulations of AFL SJ which the AFL SJ is obliged to observe by reason of any agreement between AFL NSW/ACT and the AFL SJ;
    - (ii) in so far as it affects the Club, the Rules of Incorporation of the AFL SJ;
    - (iii) any rules, regulations or by laws of the AFL SJ, as amended from time to time;
    - (iv) any determination or resolution of the AFL SJ or AFL NSW/ACT made before or after the date of this application and;
    - (v) any marketing or sponsorship commitments made on behalf of the Club by the AFL SJ in relation to use of Logos or approved equipment and/or suppliers.
    - (vi) ensure that its players compete in the competition administered by the AFL SJ in accordance with the Laws of Australian Football;
    - (vii) ensure that all players competing in the competition administered by the AFL SJ complete a registration form and remain registered whilst on the Club's list of players; and
    - (viii) maintain and ensure that each of its officers, players, officials and persons concerned in or taking part in the administration of the Club (whether paid or unpaid) maintain a high and good reputation and not jointly or severally engage in any unbecoming conduct or conduct which is prejudicial or likely to be prejudicial to the interests of the AFL, AFL NSW/ACT, the AFL SJ or the game of Australian Football.
2. The Club shall pay to the AFL SJ and to the Regional Committee annual fees for Affiliation and Regional Costs as determined by the Board and the Regional Committee from time to time.
3. The AFL SJ may terminate this Affiliation
  - (i) By giving the Club prior notice;
  - (ii) Immediately if the Club fails to comply with all or any of its obligations contained in this agreement;
  - (iii) Immediately if the Club does or permits to be done any act or thing which reflects unfavorably upon the reputation, standing or goodwill of the AFL, AFL NSW/ACT or the AFL SJ or the game of Australian Football; or
4. For affiliation to be considered, please provide a copy of the following documents:
  - (i) copy of the latest return to the Department of Fair Trading
  - (ii) copy of the latest financial statements

5. During the term of this Agreement and subject to the Club complying with the terms of this Agreement:
- (i) the Club shall be entitled to exercise its rights and obligations pursuant to this Agreement without interference from AFL Sydney Juniors; and
  - (ii) AFL Sydney Juniors shall use its best endeavours to carry on and conduct the Competition (or such other competitions) in a proper and efficient manner and to ensure that all other Clubs affiliated in such competitions observe and comply with the terms of their respective Affiliation Agreement..
  - (iii) AFL Sydney Juniors will comply with all laws generally affecting the Competition.
